

“Kindle A Light” Opportunity Drawing

OFFICIAL RULES

1. The **Grand Prize** for the Kimball Art Center Kindle A Light Opportunity Drawing is the artwork **“Alena” by Jimmi Toro (36” x 31.5”, oil on board)**. Total value is \$2,250.

For each Kindle A Light Opportunity Drawing ticket purchased between 12:01 a.m. MST on August 31, 2017 and through November 26, 2017 at 11:59 p.m. MST, the person will receive one (1) opportunity drawing entry. Each entry gives the person one chance to win the Grand Prize. The odds of winning the Grand Prize will depend upon the total number of Kindle A Light Opportunity Drawing tickets purchased.
3. All payments for entries must be made in U.S. funds.
4. Offer not valid for persons under the age of 18.
5. Kindle A Light Opportunity Drawing tickets purchased after 11:59 p.m. MST on November 26, 2017 will not qualify for entry into the Kimball Art Center Kindle A Light Opportunity Drawing. All entries will be subject to acceptance by the Kimball Art Center.
6. The Grand Prize winner will be notified in person or by certified mail, and the winner’s name will be announced by December 1, 2017 on the Kimball Art Center website, Facebook page, Twitter account and newsletter, among other methods.
7. There is no requirement that the winner live in the state of Utah. However, if the winner lives out-of-state, he/she will be required to pay any additional taxes or costs required in their state of residence, including but not limited to any shipping costs for “Alena”.
